This year has been an incredible season of growth, impact, and God's faithfulness at The WAY Center. We've been honored to walk alongside so many families and individuals as lives were strengthened and new opportunities unfolded. As we reflect on the year behind us, here are just a few of the meaningful moments and milestones that made 2025 so special. Early this year, **The WAY Center set out to Pave The WAY as our parking lot had become a safety concern and a distraction to ministry operations.** Thanks to the tremendous support of our community partners, that goal was accomplished, and by September the project was complete. **In August, we celebrated another major milestone with the opening of our second thrift store location, WAY 2 Shoppe Furniture & More.** We believe God is leading The WAY Center to expand our transitional housing program to include moms with boys over the age of 10—something our current setup does not allow. The new store is a critical step toward that vision, helping generate sustainable revenue for a future home while also providing valuable training opportunities for teen boys in areas such as stocking, inventory control, customer service, cash handling, and furniture pickup and delivery. In addition, the store serves our wider community by offering quality used furniture at affordable prices, while qualifying families can receive furniture at little to no cost based on need. **The WAY Home has been home to 7 ladies this year (4 singles and 3 with children),** 6 of which appear to be on track for great success! One resident completed the program in January and continues to celebrate her sobriety and a newfound relationship with Jesus Christ. She has also obtained gainful employment and stable housing. Another young lady was only in for a short period, but was able graduate high school and be reunited with her family. Currently, one resident graduated from Ridge Technical College, another has landed a great job with BAY Care, another is working part-time as a bookkeeper and is working toward obtaining her drivers license, while our newest resident is on track to start school in January. 😊 Beyond all this, **we have been blessed to serve nearly 600 families so far this year and we're not done yet!** Check out our year-to-date stats toward the end of this newsletter.

Holiday Outreach

The holiday season, while often filled with joy, can also bring added stress for families struggling financially. However, thanks to the generosity of many donors, we were able to bring relief and happiness to those in need. This year, 22 families received bundles of Thanksgiving food along with a gift card to select a meat of their choice, ensuring they could enjoy a hearty holiday meal. Furthermore, Christmas gifts were provided for 59 children across 25 families. Generous donors sponsored teens from qualified families, while mothers of younger children had the opportunity to select gifts at our Christmas Boutique. In addition to receiving gifts, each mother was also offered comfort and support through prayer and personal interaction when they picked up their gifts. This initiative not only met practical needs but also spread the love and hope of Jesus during a challenging time.
